To fully benefit from all these features, the customer must create and account and be logged in. In the app, the app user is able to check their account data. With the app, NIO intends to spread information on the brand, the vehicles, the events, the technology used, and the latest company updates in EU. The app will help in creating a community of the brand in EU. It provides especially the following features: Home (Community, V-Badges), Friends (Instant Messaging), Life (NIO Points) and Account (Registration and Login, Profile Maintainance, 5-star comments).

Excluded processing activities

The following functions and/or services and/or product-versions are not subject to this evaluation and have not been reviewed by the experts:

- All other functions except those listed in the "functions in scope" sheet as functions of the app

 and following subfunctions: Events (subfunction of Home), Order Goods and Payment
 (subfunctions of Life) and E-Mail Marketing (subfunction of Account)).
- Any data processing that is not shown in the functions sheets and their respective data types sheets in this document. Processing of any data types not listed in the data types sheets.
- Any data processing by (joint) controllers other than NIO GmbH. The consideration of duties, data security and other conditions at (joint) controllers other than Nio GmbH.
- Any data processing where not NIO GmbH is controller.
- Other Nio services besides NIO APP v1.9.0
- NIO APP as it is provided to users outside the EU/EEA.
- The usage of the EU/EEA-version Nio App outside of the EU/EEA
- Any other NIO services or third party services or service providers connected or associated with or using NIO App. Third-Party apps that may interact with NIO App.
- The usage of personal data by Nio or any of their affiliates or 3rd parties for purposes like but not restricted to:
 - any BI application or AI learning (this includes all activities of the BI or carried out in connection with it), or any other big data solution or data mining,
 - analytics and development purposes, including creating aggregated groups based on usage activities,
 - o targeting and directed marketing activities,
