Developer / Publisher can use AppGallery Connect to distribute their apps on AppGallery and make them available for Huawei device users.

Aspiegel Limited offers a variety of mobile services to their customers. AppGallery is an app, which allows users to browse, install and update apps available for Huawei devices. The scope of this evaluation is limited to the version of AppGallery as it is provided by Aspiegel to users in the European Union (EU)/European Economic Area (EEA).

The following functions are subject to this evaluation:

## 1. Agreement Data Flow

Obtaining the user's consent

Using AppGallery to browse, download, install and update apps

#### 3. App Search

Searching for available apps in AppGallery

Rating and commencting on installed apps

## 8. Activity and Gift Feature

Users can participate in activities and win several gifts

## **Excluded processing activities**

The following functions and/or services and/or product-versions are not subject to this evaluation and have not been reviewed by the experts:

- 1. AppGallery as it is provided to users outside the EU/EEA.
- 2. The usage of personal data by Aspiegel or any of their affiliates or 3rd parties for purposes like but not restricted to:
  - any BI application or AI learning
- Analytics and development purposes, including creating aggregated groups based on usage activities
  - Targeting and directed marketing activities
  - customer relationship management and customer care
  - support and communication
  - conducting customer surveys and customer complaint handling
  - maintenance, problem diagnosis and fixing
  - software and system updates
  - user identification

This includes also any back-end services and processes which relate to the a.m. operations.
