Definition of processing activities

Huawei ID based Trust Circle Index Service (TCIS Service) is a security feature since EMUI 5.1, which provides authentication for devices using an identical Huawei ID account and enable devices to obtain the negotiation key of same Huawei ID which is needed to authenticate to Huawei (ID). All entities authenticated via TCIS / Huawei ID will therefore be part of the "Trust Circle" of devices / entities which are trusted and further ensure that "data is only transferred among correct devices".

TCIS is a direct subsystem of Huawei ID which actually handles the authentication part for Huawei ID. TCIS Server as well as "External Server" are hosted on Apsiegel Limited (controller entity in EU, Ireland). Only data transfer between "External Server" and TCIS is the pushtoken.

Excluded processing activities

The following functions and/or services and/or product-versions are not subject to this evaluation and have not been reviewed by the experts:

1. TCIS used in version prior to EMUI 11 or above
2. TCIS as it is provided to users outside the EU/EEA.
3. The usage of personal data by Aspiegel or any of their affiliates or 3rd parties for purposes like - but not restricted to:
 - any BI application or AI learning
 - Analytics and development purposes, including creating aggregated groups based on usage activities
 - Targeting and directed marketing activities
 - customer relationship management and customer care
 - support and communication
 - conducting customer surveys and customer complaint handling
 - maintenance, problem diagnosis and fixing
 - software and system updates

This includes also any back-end services and processes which relate to the a.m. operations.
4. Other services provided by Aspiegel or any of their affiliates or any 3rd parties, that may interact with TCIS or Huawei ID.
5. Data processing of other products or services of Huawei using TCIS (like logging or all other processing of data).
6. Third-Party applications / services that may interact with TCIS (only TCIS itself is covered).
7. The usage of the EU/EEA-version of TCIS outside of the EU/EEA.
8. Examination of TOMs of any processor or controller apart from Aspiegel.
9. Other data transfers / use cases of servers mentioned as part of the infrastructure in this evaluation
10. Login using third-party services (Google, facebook, etc.)
11. Any information or data exchanged between different devices logged in HuaweiID account.
12. Any usage of the EU/EEA-version of Huawei ID by users, which have registered their Huawei ID outside of the EU/EEA.
